# 4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Painter is often employed or self-employed in the painting and maintenance industry. He carries out his work for various clients in residential and non residential construction such as homes, office buildings and hospitals. This can be either maintenance or new construction. He carries out his work on all kinds of surfaces (for example wood, stone and metal). The Painter carries out his work within relatively simple projects.

# 5. Official basis of the certificate

### Access to next level of education/professions

The Painter can specialise within the same level in certain types of paintwork. This can be achieved through courses or training in professional practice. The Painter can advance to skilled painter at level 3.

# International agreements

#### Legal basis

Act on Vocational Education and Training (WEB), registered number of qualification (crebo): 25030 The education and training for this qualification is offered as of 01-08-2015.

# 6. Officially recognised ways of acquiring the certificate

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

Average duration of the education/ training leading to the certificate

2 years (3200 study hours) (depending on previous education)

#### **Entry requirements**

The certificate preparatory vocational secondary education (vmbo) basic vocational programme, or a comparable level.

### 7. Additional information

Dutch senior secondary VET is based on qualification files, that each contain one or more qualifications. The information included in part 3 and 4 is derived directly from the qualification file determined by the Minister of Education, Culture and Science. The complete qualification file can be found at <a href="kwalificaties.s-bb.nl">kwalificaties.s-bb.nl</a>, only in Dutch.

Optional subjects are linked to the qualification. The optional subjects have a total size of 15% of the course duration. The optional subjects completed by the student are listed on the certificate.
