## 4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

A Supervisor construction works at organisations, companies and institutions within the construction/infrastructure sector, in which building and utility are designed, realised and maintained, be it a profit or non-profit organisation. The Supervisor construction is involved in designing, realising and maintaining projects and will be widely involved in multiple aspects or specialised in one task of a project phase, depending on the organisation he works at. During his tasks, he is involved in drafts, specifications, budgets/quotations, planning, constructions, permits and executive aspects, among others.

<p><b>Access to next level of education/professions</b> A Supervisor construction can develop to a wider arrange of responsibilities and directing larger and/or more complex projects. From almost any position, the Supervisor construction can specialise or develop to supervising positions with more responsibilities, provided he receives the according training/education that goes with it. Higher professional educations through which he can develop are Engineer construction, Engineer civil technology, Structural business economics, Real estate manager or a Teacher course.</p>	<p><b>International agreements</b> Supervisor construction is not a regulated profession in the Netherlands. However, the education and training for this profession on qualification level 4 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.</p>																				
<p><b>Legal basis</b> Act on Vocational Education and Training (WEB), registered number of qualification (crebo): 25104 The education and training for this qualification is offered as of 01-08-2015.</p>																					

## 6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>	
<p><b>Average duration of the education/ training leading to the certificate</b></p>	<p><b>4 years (6400 study hours) (depending on previous education)</b></p>
<p><b>Entry requirements</b> The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.</p>

<p>Dutch senior secondary VET is based on qualification files, that each contain one or more qualifications.
