A Supervisor traffic and urban development can work for various companies and (governmental) institutions within the construction/infrastructure sector. The nature of his working tasks depends on the size of the company or organisation and what the specialisation of the organisation is. In larger organisations this often concerns specialised work. In smaller organisations, the Supervisor traffic and urban development has more sorts of tasks. The Supervisor traffic and urban development works in improving, adapting, (re)organising, (re)allocating and maintaining built environments and public spaces. He provides support in designing and elaborates, presents and substantiates designs.

<p><b>Access to next level of education/professions</b>                  Depending on experience and education, a Supervisor traffic and urban development can develop to a wider range of responsibilities and to supervising larger and/or more complex projects, or to a specialised or managing position with larger responsibilities. This can be achieved through higher professional education such as Spatial planning.</p>	<p><b>International agreements</b>                  Supervisor traffic and urban development is not a regulated profession in the Netherlands. However, the education and training for this profession on qualification level 4 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.</p>

## 6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).                  In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.                  In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>	
<p><b>Average duration of the education/ training leading to the certificate</b></p>	<p><b>4 years (6400 study hours) (depending on previous education)</b></p>
<p><b>Entry requirements</b>                  The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.</p>

<p>Dutch senior secondary VET is based on qualification files, that each contain one or more qualifications. The information included in part 3 and 4 is derived directly from the qualification file determined by the Minister of Education, Culture and Science. The optional subjects have a total size of 15% of the course duration.
