<p>Access to next level of education/professions There are ways to develop through an ICT or media technology education within higher professional education: Business computer science, Computer science, Technical computer science, Information service and management, Multimedia design, Digital communication or Computer game development. In the media sector there is also a Management course in higher professional education. There are connecting educations within education structures of Microsoft and Exin among others. After additional education or based on work experience, an Application and media developer can advance to a function such as developer or programmer on a higher professional education level. This can also be a specialised function, such as senior media developer or application manager. Through expansion of knowledge, he can develop to become a general worker or to a supervising function such as project manager, team leader, department head, CTO, studio manager or coordinator.</p>	<p>International agreements Application and media developer is not a regulated profession in the Netherlands. However, the education and training for this profession on qualification level 4 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.</p>

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>

<p>Entry requirements The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.</p>
