#### 3. PROFILE OF SKILLS AND COMPETENCES

Core task 1: Carries out nautical tasks at operational level A-II/3 on fishing vessels

#### 4. Range of occupations accessible to the holder of the certificate

The Deck officer and engineer class VI (SW6) fishing fleet works on a fishing vessel. He mainly works in cutter fishing, but can also work in trawler fishing. In cutter fishing there is usually less crew on the ship than in trawler fishing. That is why the functional differentiation of the professions on a cutter is smaller than on a trawler. In the trawler sector, the SW6 can be used as a journeyman on deck for fishing activities. He is not authorized to independently keep watch on the bridge or in the engine room and he cannot be deployed as a watchman. The same applies to cutter fishing in sailing areas other than sailing area I.

Due to (inter)national legislation, the SW6 must have a certificate of competency in accordance with the Seafarers Act (certificates of competency are issued for the combination of length/propulsion power of ships with sailing areas).

The SW6 is qualified as a helmsman, engineer or skipper on a fishing vessel smaller than 24 meters, with a power of less than 3000 kW in sailing area I. Sailing area I includes all waters up to 30 nautical miles from the French,

#### 6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

#### **Entry requirements**

The certificate preparatory vocational secondary education (vmbo) basic vocational programme, or a comparable level.
