#### 4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

A Deck officer water engineering works in an internationally oriented sector. Water engineering companies carry out dredging work all over the world, both on inland waters and offshore. During his watch, the Deck officer water engineering manages the ship and is responsible for supervising the dredging production process and optimising production.

The Dredging officer deck's responsibilities may vary depending on the company he works for. He can have the

rank of deck officer and also supervise the dredger and pipe operator. When the Deck officer water engineering works as a dredger, he operates the dredging equipment himself. Otherwise, he supervises the dredger who does. The Deck officer water engineering has a double task on board. Aside from the responsibility of the dredging production process, he also carries a nautical or technical responsibility. Because of this, the Deck officer water engineering is required to possess a navigation licence, as set up by the International Convention on Standards of Training, Certification and Watchkeeping for Seafarers (STCW). Navigation licences are issued for the combination length/propulsion of ships and sailing areas.

The Deck officer water engineering must also be able to pass a maritime medical examination.

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

# Entry requirements

The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.
