He often works in a company that is mainly concerned with preserving, repairing and renewing valuable cultural-historical carpentry.

5. Official basis of the certificate

Level of the certificate (national or international)

Qualification level 4 of the Dutch VET qualification

Characteristics: non-job related skills such as tactical and strategic capacities. The professional bears his or her own responsibility, which is not only related to practical implementation in terms of monitoring and supervision, but also a more formal, organisational responsibility. The range of tasks also includes drafting new procedures.

NLQF-niveau 4 - EQF level 4 - ISCED 4A

Access to next level of education/professions

Based on experience and possibly following courses, the Specialist in carpentry restoration can progress to various positions such as foreman or an office position (planner/calculator). He can also progress in his career by becoming and independent contractor. The Specialist in carpentry restoration can transfer vertically to qualifications in higher professional education for monument restoration.

International agreements

Specialist restoration carpentry is not a regulated profession in the Netherlands. However, the education and training for this profession on qualification level 4 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.

Legal basis

Act on Vocational Education and Training (WEB), registered number of qualification (crebo): 25505 The education and training for this qualification is offered as of 01-08-2016.

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

Average duration of the education/ training leading to the certificate

1 year (1600 study hours) (depending on previous education)

Entry requirements

The certificate senior secondary vocational education (mbo) on qualification level 3, in a related discipline.

7. Additional information

Dutch senior secondary VET is based on qualification files, that each contain one or more qualifications.
