4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Restoration jointing worker often works at a jointing company. The jointing company falls under the specialized contracting sector and usually works for the B&U and sometimes the infrastructure sector. Most companies are specialized in grouting, facade cleaning or facade treatment, but there are also companies that have all disciplines. These are generally larger companies that have specialized teams.

The Restoration jointing worker maintains and restores facades of monuments (for example in repurposing), iconic buildings, buildings in a protected area, but also renovation facades in residential and non-residential construction.

<p>Access to next level of education/professions For the Restoration jointing worker, advancing to a position of All-round joiner / facade handler or foreman is possible. He is then responsible for a team of jointers or facade handlers and maintains contacts with the contractor and the office. The Restoration jointing worker can progress to related qualifications from the file Planner/operations. In addition to vertical advancement, the Restoration jointing worker can develop his career into other building professions for example bricklayer.</p>	<p>International agreements Restoration jointing worker is not a regulated profession in the Netherlands. However, the education and training for this profession on qualification level 3 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.</p>

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>

<p>Entry requirements The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.</p>

<p>Dutch senior secondary VET is based on qualification files, that each contain one or more qualifications. The optional subjects have a total size of 15% of the course duration.
