His main activities are the preparation of the implementation of an assignment and the organisation and monitoring of the implementation.

<p><b>Access to next level of education/professions</b>                  The Building site supervisor construction/infrastructure can transfer within an own organisation to a position with more responsibility for projects/works/assignments through experience and following courses. Besides, he can continue his career by becoming an entrepreneur within these sectors. Examples of such positions are project leader and chief foreman. He can also master other related specialisms within the contracting world and make a change for another adjoining sector inside or outside the sector building and infrastructure. This includes supplying industry and facilities management. Educational opportunities are related Higher Vocational Education (HBO) courses and/or cursory training aimed at specific professional activities or at entrepreneurship skills, construction engineering and civil engineering.</p>	<p><b>International agreements</b>                  Building site supervisor construction/infrastructure is not a regulated profession in the Netherlands. However, the education and training for this profession on qualification level 4 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.</p>

## 6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).                  In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.                  In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>	
<p><b>Average duration of the education/ training leading to the certificate</b></p>	<p><b>3 years (4800 study hours) (depending on previous education)</b></p>
<p><b>Entry requirements</b>                  The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.</p>

<p>Dutch senior secondary VET is based on qualification files, that each contain one or more qualifications. The optional subjects have a total size of 15% of the course duration. The optional subjects completed by the student are listed on the certificate.</p>
