4. Range of occupations accessible to the holder of the certificate

The Building site supervisor crane operating works for both small and large companies specialised in crane rental and/or (exceptional) transport with as its main activity transport including vertical transport of large and small payloads. The companies carry out crane works in different market segments such as building, infrastructure and industry.

5. Official basis of the certificate

Level of the certificate (national or international)

Qualification level 4 of the Dutch VET qualification

Characteristics: non-job related skills such as tactical and strategic capacities. The professional bears his or her own responsibility, which is not only related to practical implementation in terms of monitoring and supervision, but also a more formal, organisational responsibility. The range of tasks also includes drafting new procedures.

Access to next level of education/professions

The Building site supervisor crane operating can transfer within an own organisation to a position with more responsibility for projects/works/assignments through experience and following courses. He can also continue his career by becoming a sole proprietor within relevant sectors. Examples of such positions are project leader and main contractor. He can also master another (related) specialism within the contracting and make a transfer to another adjacent sector within or outside the building industry and infrastructure, examples are supplying industry and facilitating management. Educational possibilities include related Higher Vocational Education (HBO) courses and/or cursory education focused on specific professional activities or entrepreneur skills, mechanical engineering, civic engineering, technical management.

International agreements

Building site supervisor crane operating is not a regulated profession in the Netherlands. However, the education and training for this profession on qualification level 4 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.

Legal basis

Act on Vocational Education and Training (WEB), registered number of qualification (crebo): 25121 The education and training for this qualification is offered as of 01-08-2015.

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

Average duration of the education/ training leading to the certificate

3 years (4800 study hours) (depending on previous education)

Entry requirements

The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.

7. Additional information

Dutch senior secondary VET is based on qualification files, that each contain one or more qualifications. The information included in part 3 and 4 is derived directly from the qualification file determined by the Minister of Education, Culture and Science. The complete qualification file can be found at kwalificatioss.sepb.nl, only in Dutch.

Optional subjects are linked to the qualification. The optional subjects have a total size of 15% of the course duration. The optional subjects completed by the student are listed on the certificate.
