## 4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Mechanic metal roofs and facades works within the roofing sector. The labour takes place in constructing, maintaining and renovating civil and utility houses and buildings. The products and services are offered to contractors, housing cooperatives, (semi-) governmental institutions and private clients. The Mechanic metal roofs and facades can work for various types of companies: companies which are specialised in one or more covering materials or companies which also provide carpentry or plumbing, aside from such a specialisation. The Mechanic metal roofs and facades works on external structures that are covered with metal plates.

#### 6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>

<p><b>Entry requirements</b> The certificate preparatory vocational secondary education (vmbo) basic vocational programme, or a comparable level.</p>

<p>Dutch senior secondary VET is based on qualification files, that each contain one or more qualifications.
