## 3. PROFILE OF SKILLS AND COMPETENCES

Core task 1: Is responsible for taking care of the agribusiness product

- 1.4 Is responsible for information in the production chain

## 4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Skilled cultivation worker works on a company with both covered and uncovered crops, the cultivation of bio-based starting materials or a combination of these crops. In future this could also include new and alternative crops. He could also be employed by a breeding establishment. He could also be employed by a care farm. He works on an office, halls, open air and office work. The Skilled cultivation worker cooperates within a team and often has a leading or guiding role within a team.

Additional certification is required in doing the following tasks:

- Exterminating moles and voles - Certificate: MW (Mole & vole extermination)
- Rodent control at agricultural companies - Certificate: KBA (Rodent control agricultural companies)
- Applying crop protection - Certificate: Crop protection A

It is possible for the Skilled cultivation worker to achieve these certificates within the education.

<p><b>Access to next level of education/professions</b> The Skilled cultivation worker can be transferred to Cultivation and green technology expert for example.</p>	<p><b>International agreements</b> Skilled cultivation worker is not a regulated profession in the Netherlands. However, the education and training for this profession on qualification level 3 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.</p>																				
<p><b>Legal basis</b> Act on Vocational Education and Training (WEB), registered number of qualification (crebo): 25536 The education and training for this qualification is offered as of 01-08-2016.</p>																					

## 6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>

<p><b>Entry requirements</b> The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.</p>

<p>Dutch senior secondary VET is based on qualification files, that each contain one or more qualifications. The information included in part 3 and 4 is derived directly from the qualification file determined by the Minister of Education, Culture and Science. The optional subjects have a total size of 15% of the course duration.
