3. PROFILE OF SKILLS AND COMPETENCES

Core task 1: Is responsible for taking care of the agribusiness product

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Skilled stock farm worker can work at a company where animals are being kept for the production of milk, meat, stock, eggs or pelts. His area of expertise also includes care farming. Among other places, he works in stables or outdoors. When working in a team, he is also active as a supervisor.

Additional certification is required in the doing the following tasks:

- Exterminating moles and voles - Certificate: MW (Mole & vole extermination)
- Rodent control at agricultural companies - Certificate: KBA (Rodent control agricultural companies)
- Applying crop protection - Certificate: Crop protection A

It is possible for the Skilled stock farm worker to achieve these certificates within the education.

The certificate issued on completion of the programme is signed by the examination board at the school where the pupil attended the programme.

<p>Access to next level of education/professions The Skilled stock farm worker can develop to become a Stock farm expert. Through further education, he can also work in the animal testing sector, working specifically with agricultural pets.</p>	<p>International agreements Skilled livestock farm worker is not a regulated profession in the Netherlands. However, the education and training for this profession on qualification level 3 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.</p>

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>

<p>Entry requirements The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.</p>

<p>Dutch senior secondary VET is based on qualification files, that each contain one or more qualifications. The information included in part 3 and 4 is derived directly from the qualification file determined by the Minister of Education, Culture and Science. The optional subjects have a total size of 15% of the course duration.
