4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

A Creative craftsman works in a studio or workshop. He or she designs and produces creative craft products and places them on the market. These products consist of one or more materials such as leather, textile, glass, ceramics, wood, possibly together with other materials. The products include shoes, bags, textile materials, glass products, ceramic art or utensils and wooden utensils.

A Creative craftsman in principle works as an independent operator or freelancer, but can also be employed. He works with a wide range of clients; private individuals, companies, associations, organisations and government authorities.

<p>Access to next level of education/professions A Creative craftsman has several possible options in which to develop. Firstly, he can develop his trade from a creative perspective. A Creative craftsman can start up his own enterprise. If this enterprise is prosperous, it can grow and the Creative craftsman can hire staff. Aside from this, the Creative craftsman can receive further education. He can develop through art academy, fashion academy, or a higher professional Industrial formalisation education, in which he can develop in conceptual design and formalisation areas. Finally, a Creative craftsman can decide to take on extracurricular activities. Many Creative craftsmen provide courses and training in their own studio. It is also possible to teach through guest lectures. Furthermore, a Creative craftsman can take part as a professional in various advisory commissions and partnerships.</p>	<p>International agreements Creative craftsman is not a regulated profession in the Netherlands. However, the education and training for this profession on qualification level 4 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.</p>

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>

<p>Entry requirements The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.</p>	

7. ADDITIONAL INFORMATION

Dutch senior secondary VET is based on qualification files, that each contain one or more qualifications. The information included in part 3 and 4 is derived directly from the qualification file determined by the Minister of Education, Culture and Science. The complete qualification file can be found at kwalificaties.s-bb.nl, only in Dutch.

Optional subjects are linked to the qualification. The optional subjects have a total size of 15% of the course duration. The optional subjects completed by the student are listed on the certificate.
