The Agricultural contracting firm expert is employed by a contracting company and he carries out contract work at companies in primary production such as arable farming, horticulture and livestock farming companies. On the client's site, the Agricultural contracting firm expert contributes to the primary production, to the processing and/or transport of (residual) flows, the nature management of land and/or the generation of green energy for the company. The Agricultural contracting firm expert works at various locations, with varying tasks, products and (large) machines.

Additional certification is required in doing the following tasks: Exterminating moles and voles - certificate: MW (Mole & vole extermination) Managing crop protection - certificate: Crop protection A + Crop protection B Distributing and storing crop protecting substances - certificate: Crop protection C

He can also receive further education in the animal experimentation sector (specifically agricultural pets), provided he works in the livestock sector.	<b>International agreements</b> Agricultural contracting firm expert is not a regulated profession in the Netherlands. However, the education and training for this profession on qualification level 4 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

### **Entry requirements**

The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.
