<p>Access to next level of education/professions The Instructor senior secondary vocational education can develop further by following supplementary courses. He can follow additional training in education, counselling or assessment of participants or in new teaching concepts. The diploma Instructor senior secondary vocational education entitles the holder to transfer to higher professional education. Within higher professional education, an Instructor senior secondary vocational education can develop further. Within his field, he can follow teacher training. Transfer is also possible to broadly oriented higher professional education study courses, for example educational studies or psychology.</p>	<p>International agreements In the Netherlands, Instructor senior secondary vocational education is a regulated profession under the European directive 2005/36/EC, amended by directive 2013/55/EU.</p>

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>

<p>Dutch senior secondary VET is based on qualification files, that each contain one or more qualifications. The optional subjects have a total size of 15% of the course duration.
