4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Journeyman painter mainly works in paid employment or is self-employed in the painting and maintenance sector. He carries out his work for various clients in housing, office and industrial building, including homes, office buildings and hospitals. Both maintenance and new building projects. He carries out his work on a variety of surfaces (for example wood, stone and metal). The Journeyman painter carries out his work independently within a variety of projects, also within more complex projects.

<p>Access to next level of education/professions The Journeyman painter can advance to a middle management position (qualification file Middle management finishing, maintenance and interior with the profiles Foreman, Project manager real estate maintenance and Colour and interior advisor) or to a specialist position (qualification file Specialist painter).</p>	<p>International agreements Journeyman painter is not a regulated profession in the Netherlands. However, the education and training for this profession on qualification level 3 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.</p>

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>

<p>Entry requirements The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.</p>

<p>Dutch senior secondary VET is based on qualification files, that each contain one or more qualifications. The information included in part 3 and 4 is derived directly from the qualification file determined by the Minister of Education, Culture and Science. The optional subjects have a total size of 15% of the course duration.
