# 4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Junior navy officer (as corporal) will perform tasks on board a sailing unit. He works with working and learning assignments in a school based environment in preparation for his/her career within the Defence organisation. If he satisfies the safety, inspection and selection requirements, the Junior navy officer can be appointed as a serviceman and start work with one of the defence arms. Trainee servicemen will firstly work with one of the operational commands. If appointed to the Defence organisation and allocated to one of the operational commands, he will first follow general basic training followed by job-specific training.

The certificate issued on completion of the programme is signed by the examination board at the school where the pupil attended the programme.

## Level of the certificate (national or international)

Qualification level 3 of the Dutch VET qualification structure

Characteristics: implementation of more than just the own block of tasks. The professional is able to account for his or her actions towards colleagues, and monitors and supervises the work of others. The range of tasks also includes drafting work preparation procedures. NLQF-niveau 3 - EQF level 3 - ISCED 3C

#### Access to next level of education/professions

The study course Junior navy officer prepares for a career with the Defence organisation. After completing the study course, the Junior navy officer generally transfers to the Royal Netherlands Navy. The positions he may end up in are very wide ranging, from operational through to technical and logistic positions. Following appointment, the senior secondary vocational education diploma Junior navy officer access to the military non-commissioned officer training where noncommissioned officers complete their further military training. He will then follow part of general military training/basic training and (part of) specialist training. With the Royal Netherlands Navy, he will start as corporal. From this starting level, the non-commissioned officer can advance to the position of sergeant (1st class), sergeant-major and petty officer. Outstanding non-commissioned officers can also transfer to the highest non-commissioned officer's level: chief petty officer or certain officers ranks. The Junior navy officer can transfer to study courses such as Security coordinator, Enforcer surveillance and security, Sport and exercise coordinator or to various Supervisor position study courses (for example construction).

#### International agreements

Junior navy officer is not a regulated profession in the Netherlands. However, the education and training for this profession on qualification level 3 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.

# Legal basis

Act on Vocational Education and Training (WEB), registered number of qualification (crebo): 25602 The education and training for this qualification is offered as of 01-08-2019.

#### 6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of

vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

Average duration of the education/ training leading to the certificate 3 years (4800 study hours) (depending on previous education)

#### **Entry requirements**

The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.

# 7. Additional information

Dutch senior secondary VET is based on qualification files, that each contain one or more qualifications. The information included in part 3 and 4 is derived directly from the qualification file determined by the Minister of Education, Culture and Science. Optional subjects are linked to the qualification. The optional subjects have a total size of 15% of the course duration. The optional subjects completed by the student are listed on the certificate.
