4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

A Bodywork builder can work in production or repair/maintenance within the mobility sector. He works in companies which specialise in (re)building and maintaining/repairing various vehicles, such as (luxury) personal vehicles, two-wheeled vehicles (motorcycles, scooters, mopeds and bicycles), recreational vehicles (caravans, pop-up campers) and/or company vehicles. Furthermore he can also work at companies working in bodywork construction.

The certificate issued on completion of the programme is signed by the examination board at the school where the pupil attended the programme.

<p>Access to next level of education/professions The most obvious advancement opportunity for the Bodywork builder is to become a Skilled bodywork builder. After a number of years' work experience on the labour market, the Bodywork builder can advance to the position of Skilled bodywork builder. If the Bodywork builder has the required competences, further advancement is possible to managerial positions such as head of new construction or maintenance, workshop manager or even company manager. The Bodywork builder can continue his career outside the sector; in commercial or technical positions at suppliers/manufacturers of bodywork or in education (as a teacher of bodywork construction).</p>	<p>International agreements</p>

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>
