4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Manager floristry, green retail trade and styling works at companies focused on selling, delivering and styling flowers, plants and green arrangements. This can, for example, be a flower/plant store, a garden centre, itinerant trade or a company in interior plantation. He can also work as an independent entrepreneur/independent designer or he can work for companies which work in designing, decoration and stylizing. The Manager floristry, green retail trade and styling works on location, in the sales area, the stock room, the studio and/or the work or business space.

<p>Access to next level of education/professions With a diploma at qualification level 4, transfer is possible to higher professional education. The Manager floristry, green retail trade and styling can advance to higher professional education in the specialisations decorative flower arranging, styling and possibly entrepreneurial/business study courses.</p>	<p>International agreements Manager floristry, green retail trade and styling is not a regulated profession in the Netherlands. However, the education and training for this profession on qualification level 4 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.</p>

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>

<p>Entry requirements The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.</p>

<p>Dutch senior secondary VET is based on qualification files, that each contain one or more qualifications. The information included in part 3 and 4 is derived directly from the qualification file determined by the Minister of Education, Culture and Science.
