## 4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Salon manager ladies can lead or own various types hairdressing enterprises: specialised salons for men or women, mixed and specific hair salons. Specific hair salons include fashion-sensitive and trendy salons, aimed at treating afro haircuts for example, or another certain market segment. The majority of hairdressing businesses are mixed. There are also mobile hairdressers, these are hairdressers who visit their clients at home, nursing homes or hospitals, for example.

<p><b>Access to next level of education/professions</b> The Salon manager ladies can develop through various higher professional educations in entrepreneurship &amp; management such as Small business, Business economics, Management and Commercial law. The Salon manager ladies can develop to become an entrepreneur of multiple hair salons/branches or to positions in related enterprises such as manufacturers, hair care products or hair dressing tools.</p>	<p><b>International agreements</b> Salon manager ladies is not a regulated profession in the Netherlands. However, the education and training for this profession on qualification level 4 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.</p>																				
<p><b>Legal basis</b> Act on Vocational Education and Training (WEB), registered number of qualification (crebo): 25644 The education and training for this qualification is offered as of 01-08-2020.</p>																					

## 6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>	
<p><b>Average duration of the education/ training leading to the certificate</b></p>	<p><b>3 years (4800 study hours) (depending on previous education)</b></p>
<p><b>Entry requirements</b> The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.</p>
