maritime communication. He/she is always alert to possible unsafe situations and changing weather conditions. He/she has technical insight and repairs breakdowns. He/she works according to standard routines but also personal insight. The ship's mate/ship's engineer fishing vessels SW5 is responsible for his/her own work and partly also for the work of the crew under his/her command. Based on (inter)national legislation, the Maritime officer small ships nautical, fishery must be in possession of a certificate of competence according to the STCW convention or the STW-F convention and the Seafarers Act. Certificates of competence are issued for the combination length / propulsion / tonnage of vessels and sailing areas. The Maritime officer small ships nautical, fishery must also satisfy the medical inspection requirements for shipping.

#### 6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.
