| <p>Access to next level of education/professions Within the profession, the Pedicurist can develop further in the field of supplementary and specialist treatment and working in a multidisciplinary foot team. Advancement to the profession of Medical pedicurist is entirely possible. Other opportunities for advancement relate to such positions as: teaching instructor, company manager, assessor, podologist and as an independent business owner. Further development is possible via additional training and transfer to the qualification Medical pedicurist. Within the beauty care sector, transfer is also possible for example to beautician, the qualification All-round beautician (level 4).</p> | <p>International agreements Pedicurist is not a regulated profession in the Netherlands. However, the education and training for this profession on qualification level 3 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. | <p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p> | |
