4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Medical pedicurist exercises her profession as an entrepreneur. She has her own business and/or works as a mobile service provider. The Medical pedicurist can work in paid employment for example at a wellness centre, a podiatry practice, a care institution or a pedicurist's practice. The Medical pedicurist can also work alongside other professionals, for example in a group practice, paramedical centre, diabetes centre or multidisciplinary foot team at a hospital. The Medical pedicurist examines and treats (potential) at risk feet. In her work she deals with clients with underlying diseases and disorders that engender an increased risk of foot problems.

5. Official basis of the certificate

The certificate issued on completion of the programme is signed by the examination board at the school where the pupil attended the programme.

Level of the certificate (national or international)Qualification level 4 of the Dutch VET qualification structure

Characteristics: non-job related skills such as tactical and strategic capacities. The professional bears his or her own responsibility, which is not only related to practical implementation in terms of monitoring and supervision, but also a more formal, organisational responsibility. The range of tasks also includes drafting new procedures.

Access to next level of education/professions

Within the profession, the Medical pedicurist can develop further in the field of supplementary and specialist treatment and working in a multidisciplinary foot team. Advancement is possible to such positions as: teaching instructor, company manager, registered podologist, assessor or (commercial) positions within companies supplying foot care materials and products. Advancement is also possible as an independent business owner. For the Medical pedicurist, after completing supplementary training, advancement is possible for example to the position of podotherapist. This requires a transfer to higher professional education. Transfer to other paramedical study courses at higher professional education level is also possible such as skin therapy and physical therapy.

International agreements

Medical pedicurist is not a regulated profession in the Netherlands. However, the education and training for this profession on qualification level 4 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.

Legal basis

Act on Vocational Education and Training (WEB), registered number of qualification (crebo): 25693 The education and training for this qualification is offered as of 01-08-2021.

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

Average duration of the education/ training leading to the certificate

3 years (4800 study hours) (depending on previous education)

Entry requirements

The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.

7. Additional information

Dutch senior secondary VET is based on qualification files, that each contain one or more qualifications. The information included in part 3 and 4 is derived directly from the qualification file determined by the Minister of Education, Culture and Science. Optional subjects are linked to the qualification. The optional subjects have a total size of 15% of the course duration. The optional subjects completed by the student are listed on the certificate.
