4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

A Maritime officer class V fishing vessels works in the cutter or trawler fishery. Generally there is a smaller crew on a cutter than on a trawler. Because of this, the differentiation between positions is smaller on a cutter than it is on a trawler.

The Maritime officer class V fishing vessels is a generalist who is able to carry out nautical, fishing and technical tasks. The Maritime officer class V fishing vessels can work as a boatman, team leader, quality manager or net supervisor.

Due to national legislation, the Maritime officer class V fishing vessels must be in possession of a certificate of competency in accordance with the Seafarers Act I (certificates of competency are issued for the combination length/propulsion of fishing vessels with sea areas). This also complies with the international requirements of the International Convention on Standards of Training, Certification and Watchkeeping for Fishing Vessel Personnel, 1995, STCW(F). The Maritime officer class V fishing vessels must also be able to pass a maritime medical examination.

The diploma of Maritime officer class V fishing vessels includes a navigation licence, granted by the Dutch Ministry of Infrastructure and the Environment, as an engineer of fishery for fishing vessels up to 45 meters in size and up to 3000kW in power in an unrestricted sailing area.

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbi).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

Dutch senior secondary VET is based on qualification files, that each contain one or more qualifications. The information included in part 3 and 4 is derived directly from the qualification file determined by the Minister of Education, Culture and Science. Optional subjects are linked to the qualification. The optional subjects have a total size of 15% of the course duration. The optional subjects completed by the student are listed on the certificate.
