4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

A Deck officer all fishing vessels restricted operation area (Deck officer AVRO) generally works in trawler fishing. This involves large and complex (production) ships where multiple fishing, storing and processing methods are being used. Here, fish are processed into frozen products. On trawlers, there is a large crew and a differentiated demarcation. The Deck officer AVRO is part of a team of ship's officers and carries the responsibilities of

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

navigational watch and fishing tasks.

Due to national legislation, the Deck officer all fishing vessels AVRO must be in possession of a certificate of competency in accordance with the Seafarers Act I (certificates of competency are issued for the combination length/propulsion of fishing vessels with sea areas). This also complies with the international requirements of the International Convention on Standards of Training, Certification and Watchkeeping for Fishing Vessel Personnel, 1995, STCW(F).

The Deck officer AVRO must also be able to pass a maritime medical examination.

The diploma of Deck Officer AVRO includes a navigation licence, granted by the Dutch Ministry of Infrastructure and the Environment, as a deck officer fishery for any fishing vessel in unrestricted sailing area.

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

Entry requirements

The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.

7. ADDITIONAL INFORMATION

Dutch senior secondary VET is based on qualification files, that each contain one or more qualifications. The information included in part 3 and 4 is derived directly from the qualification file determined by the Minister of Education, Culture and Science. The complete qualification file can be found at <u>kwalificaties.s-bb.nl</u>, only in Dutch.

Optional subjects are linked to the qualification. The optional subjects have a total size of 15% of the course duration. The optional subjects completed by the student are listed on the certificate.
