4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The All-round interior craftsman furnishings upholstery works in the home decoration industry in the Retail sector, often at an SME enterprise. He/she advises on and sells a range of interior products from a shop or showroom. He/she also installs and fits interior products for the customer, for example parquet flooring, elastic floors, window decorations such as curtains, insect screens and interior sun blinds. The All-round interior craftsman furnishings upholstery can work in paid employment or as a sole trader. He/she mainly works at customer locations such as homes, shops, offices, hospitals and schools.

<p>Access to next level of education/professions After completing the study programme All-round interior craftsman furnishings upholstery (level 3), it is possible to transfer to manager retail, technical manager and craftsman business owner.</p>	<p>International agreements All-round interior craftsman furnishings upholstery is not a regulated profession in the Netherlands. However, the education and training for this profession on qualification level 3 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.</p>

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>
