4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Security officer 2 works for a large number of different private and public organisations. Security officers are seconded to a client by private security organisations or works for their own organisation. Characteristic for security work is that it is subject to a licence or specific legislation. The Security officer 2 can work as object security officer and depending on (follow-up) specialist training as personal protection officer, event security officer, (airport) security officer, shop security officer, healthcare security officer, mobile supervisor, etc. Many Security officers 2 work on secondment to a client, others perform security tasks and facility tasks for the company where they are employed.

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>

<p>Entry requirements The certificate preparatory vocational secondary education (vmbo) basic vocational programme, or a comparable level.</p>

<p>Dutch senior secondary VET is based on qualification files, that each contain one or more qualifications. The optional subjects have a total size of 15% of the course duration.
