4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Security officer 3 works for a large number of different private and public organisations. Security officers are seconded to a client or by private security organisations or work for their own organisation. Characteristic for security work is that it is subject to a licence or specific legislation. The Security officer 3 can work as object security officer and depending on (follow-up) specialist training as personal protection officer, event security officer, (airport) security officer, shop security officer, healthcare security officer, mobile supervisor, etc. Many Security officers 3 work on secondment to a client, others perform security tasks and facility tasks for the company where they are employed. The Security officer 3 operates as operating foreman in the implementation of security tasks in private and public organisations.

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.

7. Additional information

Dutch senior secondary VET is based on qualification files, that each contain one or more qualifications. The information included in part 3 and 4 is derived directly from the qualification file determined by the Minister of Education, Culture and Science. The complete qualification file can be found at kwalificaties.s-bb.nl, only in Dutch.

Optional subjects are linked to the qualification. The optional subjects have a total size of 15% of the course duration. The optional subjects completed by the student are listed on the certificate.
