4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

All-round carpenters work in the home, office and industrial building sector and are employed at various locations. These include major new build projects, small-scale new build projects or remodelling/renovation projects. They work at small, medium-sized and large construction companies. Carpenters usually work in small teams. In addition to standard carpentry work, the All-round carpenter also carries out more complex work and organises the daily work of colleagues.

The certificate issued on completion of the programme is signed by the examination board at the school where the pupil attended the programme.

<p>Access to next level of education/professions Based on study and experience, the All-round carpenter can advance to various positions such as foreman/supervisor or an office position (work planner/calculator). He can also continue his career by becoming an independent contractor. One training opportunity is transfer to the qualification file Work planning/foreman (level 4).</p>	<p>International agreements All-round carpenter is not a regulated profession in the Netherlands. However, the education and training for this profession on qualification level 3 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.</p>

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbi).</p> <p>In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.</p> <p>In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>	
<p>Average duration of the education/ training leading to the certificate</p>	<p>3 years (4800 study hours) (depending on previous education)</p>
<p>Entry requirements The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.</p>

<p>Dutch senior secondary VET is based on qualification files, that each contain one or more qualifications. The information included in part 3 and 4 is derived directly from the qualification file determined by the Minister of Education, Culture and Science. The complete qualification file can be found at kwalificaties.s-bb.nl, only in Dutch.</p> <p>Optional subjects are linked to the qualification. The optional subjects have a total size of 15% of the course duration.
