4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Arborist is employed in different types of business such as a tree surgery or landscape gardening business, municipalities, consultancy firms or land management organisations such as the National Forestry Service, Natuurmonumenten and Country Estates. The Arborist mainly works with trees in outdoor space such as gardens or public space. The planting of trees on technical structures can also be part of the work. The Arborist is subject to various laws and regulations such as the WION (Underground Networks Information Exchange Act - KLIC notification of excavation works to the Land Registry Office), traffic measures, the Nature Conservation Act and the Working Conditions Act.

The certificate issued on completion of the programme is signed by the examination board at the school where the pupil attended the programme.

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).
 In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.
 In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

Dutch senior secondary VET is based on qualification files, that each contain one or more qualifications. Optional subjects are linked to the qualification. The optional subjects have a total size of 15% of the course duration. The optional subjects completed by the student are listed on the certificate.
