## 4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Transport and logistics specialist works in a dynamic, often international environment. He/she is employed in production and trading companies, transport companies, professional goods transport operators and at companies that provide logistic services on behalf of third parties to production or trading companies, with or without their own transport department. The Transport and logistics specialist can also be employed in organisations with a storage facility, such as hospitals or organisations that organise events. He/she is employed both in the office and on the shop floor.

<p><b>Access to next level of education/professions</b> With a diploma at qualification level 4, transfer is possible to higher professional education. Following additional training and with proven competences, the Transport and logistics specialist can advance to senior management positions in transport, forwarding and warehousing. Horizontal transfer is also possible for example to distribution manager or warehouse manager. The Transport and logistics specialist can also move into operating his/her own business.</p>	<p><b>International agreements</b> Transport and logistics specialist is not a regulated profession in the Netherlands. However, the education and training for this profession on qualification level 4 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.</p>																				
<p><b>Legal basis</b> Act on Vocational Education and Training (WEB), registered number of qualification (crebo): 25777 The education and training for this qualification is offered as of 01-08-2022.</p>																					

## 6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>	
<p><b>Average duration of the education/ training leading to the certificate</b></p>	<p><b>4 years (6400 study hours) (depending on previous education)</b></p>
<p><b>Entry requirements</b> The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.</p>

<p>Dutch senior secondary VET is based on qualification files, that each contain one or more qualifications.
