4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

An All-round skilled worker maintenance and renovation company (ASWMR) works on building sections and facilities etc. of houses and utility (such as hotels, care institutions, recreational parks and retailers, community centres, schools, defence buildings, mechanical engineering installations, woodwork, masonry, tiling, stuccowork and painting work. He works for a company carrying out maintenance and renovation on their own real estate, either at a company being hired to do this or as a freelancer. The ASWMR carries out his working tasks within both small clear-cut and more complex projects. He/she manages a small team and knows exactly which employee fits the job.

This document is designed to provide additional information about the specified certificate and does not have any legal status in itself. However, the education and training for this profession on qualification level 3 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. 6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>
