<p>The Asphalt worker works in the civil and hydraulic engineering sector, part of the building and infrastructure industry. He is employed by small, medium-sized and large enterprises or is self-employed. Together with the machine operator, the Asphalt worker operates the asphalt laying machine. The Asphalt worker operates the finishing beam and the machine operator steers the machine. Together they are part of the asphaltting team.</p>

<p>Access to next level of education/professions Depending on the size of the company, based on experience and study, the Asphalt worker can advance to the position of foreman, supervisor, planner or work scheduler. He can also advance to sector middle management study courses and study courses at level 4 in the qualification structure, for example qualifications from the file Work planning/supervision.</p>	<p>International agreements Asphalt worker is not a regulated profession in the Netherlands. However, the education and training for this profession on qualification level 3 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.</p>

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>

<p>Entry requirements The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.</p>

<p>Dutch senior secondary VET is based on qualification files, that each contain one or more qualifications. The information included in part 3 and 4 is derived directly from the qualification file determined by the Minister of Education, Culture and Science. The optional subjects have a total size of 15% of the course duration.
