4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The All-round water engineering officer is employed in the civil and hydraulic engineering sector, part of the building and infrastructure industry. He is employed for small, medium-sized and large enterprises or is self-employed. The All-round water engineering officer works out of doors, mainly alongside or on waterways. The primary tasks of the All-round water engineering officer are: Building, maintaining and removing hydraulic engineering structures such as small engineering structures and bank structures.

<p>Access to next level of education/professions Depending on the size of the company, based on experience and study, the All-round water engineering officer can advance to the position of foreman, supervisor, planner or work scheduler. He can also advance to sector middle management study courses and study courses at level 4 in the qualification structure, for example qualifications from the file Work planning/supervision.</p>	<p>International agreements All-round water engineering officer is not a regulated profession in the Netherlands. However, the education and training for this profession on qualification level 3 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.</p>

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>

<p>Entry requirements The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.</p>

<p>Dutch senior secondary VET is based on qualification files, that each contain one or more qualifications.
