## 4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Skilled worker equestrian sports and horse farm works on horse farms such as breeding farms, stud farms and rearing farms or farms involved in sport and recreation such as equine sport and horse trading stables, retirement stables and riding stables. He interacts with different types of equine sports associations and licencing organisations. The Skilled worker equestrian sports and horse farm is mainly involved in the daily care and exercise of horses.

<p><b>Access to next level of education/professions</b> The Skilled worker equestrian sports and horse farm can advance horizontally to farms where other types of animals are kept (dairy cattle, grazing animals and livestock) and advance vertically to the qualification Manager equestrian sports and horse farm or Instructor equestrian sports and horse farm.</p>	<p><b>International agreements</b> Skilled worker equestrian sports and horse farm is not a regulated profession in the Netherlands. However, the education and training for this profession on qualification level 3 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.</p>																				
<p><b>Legal basis</b> Act on Vocational Education and Training (WEB), registered number of qualification (crebo): 25915 The education and training for this qualification is offered as of 01-08-2023.</p>																					

## 6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>	
<p><b>Average duration of the education/ training leading to the certificate</b></p>	<p><b>3 years (4800 study hours) (depending on previous education)</b></p>
<p><b>Entry requirements</b> The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.</p>

<p>Dutch senior secondary VET is based on qualification files, that each contain one or more qualifications.
