4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Manager equestrian sports and horse farm works on horse farms such as breeding farms, stud farms and rearing farms or farms involved in sport and recreation such as equine sport and horse trading stables, retirement stables and riding stables. He interacts with different types of equine sports associations and licencing organisations. The Manager equestrian sports and horse farm is in charge of the farm and supports the business owner. He is responsible for the daily care of the horses.

<p>Access to next level of education/professions The Manager equestrian sports and horse farm can transfer onto the labour market as a business owner or farm manager at (larger) farms within horse farming. Advancement is also possible through expanding the farm for example to include recreation or nature and landscape management. This may require additional training. The Manager equestrian sports and horse farm can develop their own riding skills and didactic capacity and develop to the position of instructor at a higher level. Transfer to higher professional education is possible for the subject Equine management and animal management.</p>	<p>International agreements Manager equestrian sports and horse farm is not a regulated profession in the Netherlands. However, the education and training for this profession on qualification level 4 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.</p>

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).
In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.
In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.
