### 4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Instructor equestrian sports and horse farm works on horse farms such as breeding farms, stud farms and rearing farms or farms involved in sport and recreation such as equine sport and horse trading stables, retirement stables and riding stables. He interacts with different types of equine sports associations and licencing organisations. The Instructor equestrian sports and horse farm offers riding lessons/training and trains horses at a higher level than the Skilled worker equestrian sports and horse farm and the Manager equestrian sports and horse farm.

The certificate issued on completion of the programme is signed by the examination board at the school where the pupil attended the programme.

# Level of the certificate (national or international)

Qualification level 4 of the Dutch VET qualification structure

Characteristics: non-job related skills such as tactical and strategic capacities. The professional bears his or her own responsibility, which is not only related to practical implementation in terms of monitoring and supervision, but also a more formal, organisational responsibility. The range of tasks also includes drafting new procedures.

# Access to next level of education/professions

The Instructor equestrian sports and horse farm can transfer to a position as sport manager if he/she also acquires technical sport-based skills, can specialise in equine sport discipline or working with a specific target group. Transfer to higher professional education is possible for the subject Equine management and animal management.

## International agreements

Instructor equestrian sports and horse farm is not a regulated profession in the Netherlands. However, the education and training for this profession on qualification level 4 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.

#### Legal basis

Act on Vocational Education and Training (WEB), registered number of qualification (crebo): 25917 The education and training for this qualification is offered as of 01-08-2023.

### 6. Officially recognised ways of acquiring the certificate

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

### **Entry requirements**

The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.
