The Farrier almost exclusively works as an independent business owner on the farm/land of the customer or owner, where he/she provides a service relating to the hoofs of horses and ponies. In certain cases he/she works with a number of employees or is employed by a veterinary practice or animal clinic.

<p>Access to next level of education/professions The Farrier is trained to start on the labour market as an independent business owner. Via the top-up course entrepreneurship, he/she can advance to level 4. The Farrier can specialise in horses for a particular sport discipline or in therapeutic and corrective horseshoes for horses and ponies with bone deformities, bone defects and hoof diseases. The demanding physical burden and growing competition are resulting in the presence of more part-timers. In addition to Farriering, they often start other activities of a wide-ranging nature: for example horse trading, decorative Farriering work or insurance assessor. Training is required for each of these activities.</p>	<p>International agreements Farrier is not a regulated profession in the Netherlands. However, the education and training for this profession on qualification level 3 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.</p>

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>
