## 3. PROFILE OF SKILLS AND COMPETENCES

Core task 1: Installs electrotechnical installations

- 1.1 Does preparatory work for electrotechnical installation activities
- 1.2 Disassembles and repairs electrotechnical components and pipes
- 1.3 Checks and fits components in electrotechnical installations and systems
- 1.4 Installs cables for electrotechnical installations and systems
- 1.5 Completes electrotechnical installation work

Core task 2: Supervising and implementing electrical installation work in the built environment

- 2.1 Assembles, checks and tests (complex) (sub) products in the built environment
- 2.2 Determines the position and route of components, cables and wires in the built environment, reads drawings and updates data
- 2.3 Switches on and tests electrotechnical installations in the built environment
- 2.4 Instructs and supervises mechanics and monitors planning
- 2.5 Communicates and consults with stakeholders

## 4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Skilled mechanic electrotechnical installations in the built environment is employed in the engineering industry in a company that (also) manufactures, installs, repairs, renovates and/or dismantles and alters electrical engineering installations and systems. He works at industrial and non-industrial companies and for private individuals. The companies are both large and small in size, and may operate regionally, nationally and internationally. The Skilled mechanic electrotechnical installations in the built environment performs his work at a variety of locations, for example in houses, residential buildings, retail companies, the built environment, the industrial environment, utilities buildings (such as schools, office buildings and hospitals) and in outdoor areas. Pre-manufacturing work can also be performed in a workshop at the company.

**Name and status of the body awarding the certificate**

The certificate issued on completion of the programme is signed by the examination board at the school where the pupil attended the programme.

For example to Electrotechnical installations and systems, where a choice can be made for the study programme Technician electrotechnical industrial installations and systems or Technician electrotechnical installations houses and utility. From there, it is possible to transfer to higher professional education Electrical engineering or related technical study programmes, including short higher professional education versions or an Associate Degree. | <b>International agreements</b><br>Skilled mechanic electrotechnical installations in the built environment is not a regulated profession in the Netherlands. However, the education and training for this profession on qualification level 3 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive. |

The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.<br>In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution. |                                                                     |
