4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Manager mobility sector sells products (such as vehicles, vessels (motorised) two-wheelers, spare parts/functions and/or services (such as lease contracts, subscriptions and work to be carried out on vehicles/vessels/two-wheelers and the related parts and working hours) to (potential) private and/or business customers. He/she is employed in companies involved in the sale of (different) transport modalities and mobility concepts. The size of the company where the starting professional works ranges from small (e.g. margueindependent family businesses) to large (e.g. internationally operating mobility companies). The Manager mobility sector is in charge of the department.

5. Official basis of the certificate

The certificate issued on completion of the programme is signed by the examination board at the school where the pupil attended the programme.

Level of the certificate (national or international)Qualification level 4 of the Dutch VET qualification structure

Characteristics: non-job related skills such as tactical and strategic capacities. The professional bears his or her own responsibility, which is not only related to practical implementation in terms of monitoring and supervision, but also a more formal, organisational responsibility. The range of tasks also includes drafting new procedures.

Access to next level of education/professions

After completing the diploma Manager mobility sector (context sales or after sales) at level 4, the Manager mobility sector can obtain a second diploma at level 4. There are also various higher professional education study courses that tie in with the prior education. Possibilities include study courses in automotive engineering, teacher motor vehicle mechanics (also part-time and full time), Retail management or Small business and retail management. There are also parttime and fulltime higher professional education study courses that train for the profession of teacher motor vehicle mechanics, for example the part-time study course Teacher motor vehicle mechanics. Within the mobility sector there are various transfer opportunities from Sales manager through to Commercial Director or Director/Company manager.

International agreements

Manager mobility sector is not a regulated profession in the Netherlands. However, the education and training for this profession on qualification level 4 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.

Legal basis

Act on Vocational Education and Training (WEB), registered number of qualification (crebo): 25713 The education and training for this qualification is offered as of 01-08-2022.

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

Average duration of the education/ training leading to the certificate

3 years (4800 study hours) (depending on previous education)

Entry requirements

The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.

7. Additional information

Dutch senior secondary VET is based on qualification files, that each contain one or more qualifications. The information included in part 3 and 4 is derived directly from the qualification file determined by the Minister of Education, Culture and Science. Optional subjects are linked to the qualification. The optional subjects have a total size of 15% of the course duration. The optional subjects completed by the student are listed on the certificate.
