The Advisor mobility sector sells products (such as vehicles, vessels (motorised) two-wheelers, spare parts/functions and/or services (such as lease contracts, subscriptions and work to be carried out on vehicles/vessels/two-wheelers and the related parts and working hours) to (potential) private and/or business customers. He/she is employed in companies involved in the sale of (different) transport modalities and mobility concepts. The size of the company where the starting professional works ranges from small (e.g. marque-independent family businesses) to large (e.g. internationally operating mobility companies).

There are also part-time and fulltime higher professional education study courses that train for the profession of teacher motor vehicle mechanics, for example the part-time study course Teacher motor vehicle mechanics.</p>	<p>International agreements Advisor mobility sector is not a regulated profession in the Netherlands. However, the education and training for this profession on qualification level 3 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.</p>

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>

<p>Entry requirements The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.</p>

<p>Dutch senior secondary VET is based on qualification files, that each contain one or more qualifications. The information included in part 3 and 4 is derived directly from the qualification file determined by the Minister of Education, Culture and Science. The optional subjects have a total size of 15% of the course duration.
