4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

A Commercial job placement consultant is (generally) employed at a (hybrid) flex enterprise (SME) with as core activity mediating between vacancies and candidates. This mainly involved flexible enterprises involved in secondment, recruitment and selection and job placement for self-employed persons without employees. For the flex sector, key sectors include industry, transport, logistics, healthcare, trade, construction and government. Commonly used alternative names for the Commercial job placement consultant are job mediator, recruiter, branch assistant temporary employment agency, secondment assistant and commercial job placement advisor.

For example to the study programmes Commercial economics, E-commerce, Human resources, Marketing communication and International business and Commerce.</p>	<p>International agreements Commercial job placement consultant is not a regulated profession in the Netherlands. However, the education and training for this profession on qualification level 4 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.</p>

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>

<p>Entry requirements The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.</p>
