4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

Enforcement officer surveillance and security (domain VI) tracing and investigation. The entry-level professional works outside in public areas or public spaces, but may also be employed indoors. For example in the control room for camera surveillance.

The entry-level professional, after completing the required examinations (under the auspices of the Examination Board for Supervision and Enforcement (ExTH), has the basic competences of the Special investigating officer (BOA). BOAs have the authority to investigate and, in certain cases, police authorities (such as the use of force

<p>Access to next level of education/professions With a diploma at qualification level 3, transfer is possible to a course at qualification level 4. For example to Legal administrative worker or to Manager team/department/project. Within their domain, professionals can advance to the position of Senior enforcement officer, Manager or Coordinator. Also, after completing additional study courses at higher professional education level, advancement is possible to the position of Policy officer within a supervisory organisation, for example city surveillance. Based on the basic competences of Special investigating officer (BOA), it is possible to transfer to another domain. Additional training and compliance with the requirements from permanent retraining and in-service training (PHB) applicable for that domain are the preconditions.</p>	<p>International agreements Enforcement officer surveillance and security (domain VI) tracing and investigation is not a regulated profession in the Netherlands. However, the education and training for this profession on qualification level 3 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.</p>

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).
In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.
In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

7. ADDITIONAL INFORMATION

Dutch senior secondary VET is based on qualification files, that each contain one or more qualifications. The information included in part 3 and 4 is derived directly from the qualification file determined by the Minister of Education, Culture and Science. Optional subjects are linked to the qualification. The optional subjects have a total size of 15% of the course duration. The optional subjects completed by the student are listed on the certificate.
