3. PROFILE OF SKILLS AND COMPETENCES

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The All-round stage and event technician works for organisations responsible for the engineering aspects of stage productions. Examples include: theatres, production companies, events, festivals and pop stages, rental companies for stage equipment, specialist employment agencies.

<p>Access to next level of education/professions Advancement to a higher level within the field is possible. With a diploma at qualification level 4, transfer is possible to higher professional education. The All-round stage and event technician can transfer to higher professional education theatre technique (or a comparable but broad higher professional education programme).</p>	<p>International agreements All-round stage and event technician is not a regulated profession in the Netherlands. However, the education and training for this profession on qualification level 4 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.</p>

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>

<p>Entry requirements The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.</p>
