## 4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The All-round assistant audiovisual production works in audiovisual production companies. These companies come in all shapes and sizes; from large audiovisual production companies through to independent operators who are insourced or who work as sole traders. There are two different disciplines: film/video and photography. Some companies offer both disciplines to their clients, but even in that situation production is almost always entrusted to separate specialists.

<p><b>Access to next level of education/professions</b>  With a diploma at qualification level 3, transfer is possible to a course at qualification level 4.  The All-round assistant audiovisual production can as a rule transfer to the study programme for audiovisual specialist, without major content-based problems.</p>	<p><b>International agreements</b>  All-round assistant audiovisual production is not a regulated profession in the Netherlands. However, the education and training for this profession on qualification level 3 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.</p>																				
<p><b>Legal basis</b>  Act on Vocational Education and Training (WEB), registered number of qualification (crebo): 25716  The education and training for this qualification is offered as of 01-08-2022.</p>																					

## 6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbi).  In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.  In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>	
<p><b>Average duration of the education/ training leading to the certificate</b></p>	<p><b>3 years (4800 study hours) (depending on previous education)</b></p>
<p><b>Entry requirements</b>  The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.</p>

<p>Dutch senior secondary VET is based on qualification files, that each contain one or more qualifications. The information included in part 3 and 4 is derived directly from the qualification file determined by the Minister of Education, Culture and Science. The optional subjects have a total size of 15% of the course duration.
