3. PROFILE OF SKILLS AND COMPETENCES

Core task 1: Loads, unloads, checks and transports cargo in a port area

- 1.1 Prepares the loading, unloading, transport and/or storage of cargo
- 1.2 Carries out the loading, unloading, transport and/or storage of cargo
- 1.3 Checks the cargo

Core task 2: Ensures safe and damage-free transport

- 2.1 Prepares the shoring, releasing and stowing of cargo and/or transport equipment
- 2.2 Stoves and/or shores cargo and/or transport equipment and releases cargo and/or transport equipment
- 2.3 Completes stowing, shoring and release of cargo and/or transport equipment

Core task 3: Supervises operational stevedoring work

- 3.1 Monitors the progress and manages the implementation of the operational stevedoring tasks
- 3.2 Ensures the adequate use of tools, equipment and materials
- 3.3 Records and reports on information relating to the operational stevedoring tasks

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Skilled worker port operations works at a company in or near the port involved in the loading, unloading and storage of cargo. Depending on the type of cargo, he/she works at a general cargo company, roro company, container transshipment company, bulk company or storage and distribution company. The Skilled worker port operations is the link between the assistant and the coordinator port operations.

The certificate issued on completion of the programme is signed by the examination board at the school where the pupil attended the programme.

<p>Access to next level of education/professions After several years of practical experience and an additional senior secondary vocational education study course Coordinator port operations (level 4), the Skilled worker port operations can advance to the position of Coordinator port operations.</p>	<p>International agreements Skilled worker port operations is not a regulated profession in the Netherlands. However, the education and training for this profession on qualification level 3 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.</p>

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>

<p>Entry requirements The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.</p>

<p>Dutch senior secondary VET is based on qualification files, that each contain one or more qualifications. The information included in part 3 and 4 is derived directly from the qualification file determined by the Minister of Education, Culture and Science. The optional subjects have a total size of 15% of the course duration.
