3. PROFILE OF SKILLS AND COMPETENCES

4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Coordinator port operations works at a company in or near the port involved in the loading, unloading and storage of cargo. Depending on the type of cargo, he/she works at a general cargo company, roro company, container transhipment company, bulk company or storage and distribution company. The Coordinator port operations is skilled in a variety of control functions. Part of his/her work, namely the planning and dispatching of the work to be undertaken (organising terminal movements) using automated systems may take place in an office environment.

Access to next level of education/professions During the course of his career, the Coordinator port operations will develop further to a position of all-round assistant at an open transhipment terminal such as a stevedore. The total logistic process within the company will increasingly become the field of work of the Coordinator port operations. After obtaining this qualification, the Coordinator port operations can transfer to various higher professional education study courses.	International agreements Coordinator port operations is not a regulated profession in the Netherlands. However, the education and training for this profession on qualification level 4 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.

Act on Vocational Education and Training (WEB), registered number of qualification (crebo): 25902 The education and training for this qualification is offered as of 01-08-2023.

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).

In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.

In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.

Entry requirements

The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.

7. ADDITIONAL INFORMATION

Dutch senior secondary VET is based on qualification files, that each contain one or more qualifications. The information included in part 3 and 4 is derived directly from the qualification file determined by the Minister of Education, Culture and Science. Optional subjects are linked to the qualification. The optional subjects have a total size of 15% of the course duration. The optional subjects completed by the student are listed on the certificate.
