4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Supervisor construction works in the building/infrastructure sector at organisations, businesses and institutions that design, realise, manage and maintain the civil and office environment, as profit or non-profit organisations. He is involved in the design, realisation and maintenance of projects and depending on the organisation in which he is employed will be more broadly involved in multiple aspects or perform a more specialist task relating to a project phase. In his work he will make use of drawings, schedules of requirements, budgets/offers, timetables, structures, permits and implementation aspects.

<p>Access to next level of education/professions The Supervisor construction can advance to more responsibilities and managing larger and/or more complex projects or specialise further. This requires following additional courses, training programmes or obtaining senior secondary vocational education certificates. Examples are further specialisation towards realisation, work planning, calculation or construction. The Supervisor construction can also advance to management positions. Within senior secondary vocational education it is possible, following completion of the study programme, to follow the one-year preliminary course 'Management based on professional skills'. There are also numerous other training possibilities in related higher professional education (hbo) study programmes such as hbo Construction engineering, hbo Civil engineering, hbo Urban design or hbo Built Environment.</p>	<p>International agreements Supervisor construction is not a regulated profession in the Netherlands. However, the education and training for this profession on qualification level 4 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.</p>

6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl). In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week. In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>

<p>Entry requirements The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.</p>	

7. ADDITIONAL INFORMATION

Dutch senior secondary VET is based on qualification files, that each contain one or more qualifications. The information included in part 3 and 4 is derived directly from the qualification file determined by the Minister of Education, Culture and Science. The complete qualification file can be found at kwalificaties.s-bb.nl, only in Dutch.

Optional subjects are linked to the qualification. The optional subjects have a total size of 15% of the course duration. The optional subjects completed by the student are listed on the certificate.
