## 4. RANGE OF OCCUPATIONS ACCESSIBLE TO THE HOLDER OF THE CERTIFICATE

The Supervisor traffic and urban development works in the building/infrastructure sector for government, firms of businesses. The nature of the work depends on the size of the company or organisation and the degree of specialisation of the organisation. At larger organisations, the work is often more specialised, while in smaller companies, the Supervisor traffic and urban development performs a variety of tasks. The Supervisor traffic and urban development carries out work in the built environment in public space. This involves improving, adapting, (re) designing and (re) organising that environment. He assists in the design work, elaborates designs and prepares presentations and supporting documents.

The certificate issued on completion of the programme is signed by the examination board at the school where the pupil attended the programme.

<p><b>Access to next level of education/professions</b>                  The Supervisor traffic and urban development can advance to more responsibilities and managing larger and/or more complex projects or specialise further. This requires following additional courses, training programmes or obtaining senior secondary vocational education certificates. Examples are further specialisation towards realisation, work planning, calculation or construction. The Supervisor traffic and urban development can also advance to management positions. Within senior secondary vocational education it is possible, following completion of the study programme, to follow the one-year preliminary course 'Management based on professional skills'. There are also numerous other training possibilities in related higher professional education (hbo) study programmes such as hbo Construction engineering, hbo Civil engineering, hbo Urban design or hbo Built Environment.</p>	<p><b>International agreements</b>                  Supervisor traffic and urban development is not a regulated profession in the Netherlands. However, the education and training for this profession on qualification level 4 is regulated under the European directive 2005/36/EC, amended by directive 2013/55/EU. The regulated education and training gives access to regulated professions at the level of a diploma according to article 11 of this directive.</p>

## 6. OFFICIALLY RECOGNISED WAYS OF ACQUIRING THE CERTIFICATE

<p>Senior secondary vocational education features two learning pathways: the school-based pathway (bol) and the training on the job pathway (bbl).                  In the school-based pathway, the majority of the course consists of theory at school. The extent of the practical component (vocational practice) is between 20% and 60%. In the training on the job pathway, the extent of vocational practice is at least 60% of the course. The participant works four days a week in a training company, and attends school for theory subjects just one day a week.                  In principle it is possible to follow both learning pathways, but which pathway is offered will depend on the individual educational institution.</p>	
<p><b>Average duration of the education/ training leading to the certificate</b></p>	<p><b>4 years (6400 study hours) (depending on previous education)</b></p>
<p><b>Entry requirements</b>                  The certificate preparatory vocational secondary education (vmbo) advanced vocational programme, combined programme, or theoretical programme, or a comparable level.</p>
